Renovation Work Slated to Begin Next Month on Historic Bus Tunnel

Work is slated to start at the end of March to repair and renovate the historic East Side

Transit Tunnel in Providence. This critical piece of transit infrastructure was built in 1914 to help former trolley lines reach the top of College Hill as they traveled from downtown Providence to the East Side and beyond. The tunnel is still a vital connector today, allowing buses to avoid the steep incline of College Hill.

The project will include improving lighting and drainage in the tunnel, replacing the concrete coating inside the tunnel, asphalt repaving and refurbishing the historic bus shelter at the west end of the tunnel on North Main Street.

Work is expected to last from the end of March through mid-September, with the specific start date being weather dependent. The tunnel will be closed for the duration of the project and detours will be announced although no impact on travel times is expected. Routes 1, 32, 33, 34, and 40 will be affected.

The proposed changes are the direct result of a critical workforce shortage. Despite extensive recruitment efforts by RIPTA, drivers continue to retire more quickly than new

ones can be hired. The Authority is one of dozens in the country facing the same labor challenges and difficult decisions due to the driver shortage.

RIPTA is proposing changes to Routes 4, 6, 9x, 13, 14, 16, 18, 21, 29, 30, 51, 54, 58, 64, 65x, 69, 71, 72, 75, 87, 92 and 95x and the elimination of Routes QX, 10x, 12x, 23, 59x, 61x, 68, 73, 76, 80 and 88. Additionally, emergency temporary service changes made in Fall 2022 to Routes 22, 27, 28, 31, 50, 55, 56, 57, 60, 63, and 67 will also be addressed.

Employee Spotlight

Marc Abbott, Systems Performance Analyst

Details and data are at the heart of Marc Abbott's work for RIPTA. As a Systems Performance Analyst, he compiles spreadsheets and reports that track vital data which helps the transit authority run as efficiently as possible. In particular, he looks at ridership numbers, patterns and trends.

"I love what I do, because I know that the information I give our executive staff allows them to make decisions based on sound data," Abbott said. Nearly two years ago, he joined RIPTA after a career in the military and government, where he consistently prioritized accuracy in reporting information and working with good data. Abbott served 22 years in the Rhode Island National Guard, four years in the Army Reserve, and worked full time as a civilian employee for the U.S. Department of Defense.

He has held several positions, but said he found his passion for data when he was assigned to the U.S. Property & Fiscal Office as an analyst. It was his job to keep track of inventory and make sure that any units that were deployed had every piece of equipment they needed, "And if we didn't have it," he says. "It was my job to find it." He held a similar position at the U.S. Army Soldier Systems Center in Natick, MA before retiring in 2019.

Saying that Abbott likes to be busy is an understatement. Following his military retirement, he held a number of jobs including driving cranes before he decided to apply to RIPTA. "I like a challenge," Abbott said. "I like to take something that's complicated and make it easy for people to understand." He says being at RIPTA feels like a great fit, and he likes being part of an agency that is dedicated to serving the public.
